Capital District Agility Fun Group

SEASON 19- Winter 2023-2024

The Capital District Agility Fun Group (CDAFG) is a group of dog agility enthusiasts from several agility and/or dog clubs and training organizations in the greater New York Capital District who have agreed to train together at the locations and times specified below. CDAFG exists to provide agility trial training within a competitive setting location. CDAFG offers participants the opportunity to prepare for competition with agility courses designed to test handling skills and strategy skills.

Each CDAFG match will consist of handlers and dogs attempting two different courses – a standard course and a games course. Each session will begin with the first dog on the line no later than 9:30 AM and all runs should be completed by approximately noon (except for as noted otherwise, see schedule below). See Rules and Guidelines for complete information. IMPORTANT The site does not open until 8:45 AM. Please do not arrive before that time.

To be eligible, participants (dogs and handlers) must have completed a Novice Competition class or equivalent, or must have participated in at least one agility trial in the past year. Dogs must be healthy, trained, and at least 12 months old. Bitches in season or any dogs who are blind, lame, or aggressive towards people or other animals are not eligible to participate. The safety of the dogs is our primary concern. By entering this agility group, handlers and owners acknowledge that they are familiar with the rules and guidelines of the CDAFG, and that their dogs are familiar with and able to perform all obstacles safely.

Per the Rules and Guidelines of the CDAFG, participants may include those who do not belong to any of the affiliated organizations but who are invited to participate in the CDAFG by such a member.

All matches will be held at AgileDogs @Jazz, 37 S Greenfield Rd, Greenfield Center NY again this year. We will not be providing breakfast, snacks or coffee. Weather permitting, participants will enter at the front of the building and exit at the rear. There is no crating in the training building. You may crate out of your car or use the adjacent playpen. We only allow the dog running and the next 2 dogs in line in the training building.

Entries, Opening Postmark Date, and Closing Date

ENTRIES ARE OPEN NOW. All entries must be received by mail and must be RECEIVED BY December 14, 2023 No entries will be returned unless a SASE is provided. Handlers may enter up to 2 dogs for each session or may alternate 2 dogs from week-to-week. You may also sign up for individual weeks, pre-register \$15.00, No day of show, dogs must be on the gate sheet to run. Please email chris@agiledogs.net by the Thursday before the match you would like to attend if you don't wish to sign up for the entire season.

Except for extenuating circumstances, such as injury, dogs to be run for the season for each handler must be declared during registration on the form that follows.

Sunday March 3 is the makeup day if we have to cancel any matches.

This calendar is subject to change due to inclement weather or unforeseen problems with the training venue. In the event of inclement weather, all participants will be notified of any delays or cancellations on the website.

The CDAFG rules, and each event's courses, schedule, results, and other notices will be posted to www.cdafg.com no later than Thursday evening.

Registration Fees: The registration fee is \$75 for each handler for the season for a maximum of 6 matches. If running a 2nd dog in the same matches as the 1st dog, the fee is \$60 for the 2nd dog, same handler, for a total of \$135. If one handler is alternating dogs and not running both dogs in the in the same matches, the fee is \$75 for the season for a maximum of 6 matches. Please submit payment with your registration form and signed waiver. The returned check fee is \$30. *Make checks payable to Bob Domfort.* **NOTE: checks will not be returned if unused; they will be destroyed.**

Entry fees will <u>not</u> be refunded in the event that a dog is absent, dismissed, excused, or barred from participation by action of the CDAFG coordinators

A withdrawal from the CDAFG after the closing date due to an injury and/or illness to the dog or for bitches that come into season after the closing date will be eligible for a refund of 75% of the total entry fees paid for <u>remaining</u> matches.

No entry fees will be refunded if any match cannot be held or completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the CDAFG. In the event of a cancellation due to inclement weather, every effort will be made to reschedule the missed match; if this is not possible, refunds of unused fees will be made with funds as available.

As always, all fees will be used to cover expenses associated with the league.
